




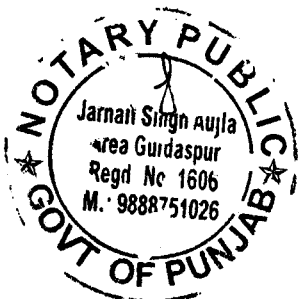
AFFIDAVIT
